A Closer Look: Professional Development in the San Diego County Preschool for All Demonstration Project

Improving the quality of preschool experiences for children and their families is a primary focus of the San Diego County Preschool for All (SDCPFA) Demonstration Project.

Preliminary analysis of data from last year indicates that preschool sessions involved in

the project experienced the most dramatic improvement in program quality to date. 80% of preschool classroom sessions scored high enough on their external review results to increase by at least one tier-level according to the SDCPFA Quality Criteria.

This growth is attributed to many factors within the realm of professional development. The purpose of this article is to

discuss some of the Professional Development support offered through SDCPFA in collaboration with the hard work that SDCPFA preschools puts forth toward the overall improvement of their programs.

The following is an interview with Sandi Meschoulam, SDCPFA Professional Development Specialist, which covers the past, present, and future of Professional Development in the SDCPFA Demonstration Project.

Q: Were you surprised to see such dramatic improvements in quality last year?

SM: Not at all surprised, but more thrilled that there was documentation of the efforts made by so many instructional staff at all the SDCPFA agencies. The coaching team has the opportunity to see so many effective changes taking place and it is wonderful to have assessment data that shows improvements in concrete terms.

This is only the first step in making visible the quality of all the classrooms. We really hope to share even more visual documentation that will tell the story of great practices in the SDCPFA community of preschools.



Q: What was the single most important thing that the SDCPFA Professional Development Team did to improve quality?

SM: The coaches on the Professional Development Team are very intentional in providing technical support. It always starts by building a relationship with the teacher and the agency, but observation and discussion always consider the external review assessment results and the child level outcomes.

In reflection on classroom strengths and areas for improvement, specific goals are determined with the teacher. At a later visit, actions taken are recorded to demonstrate how the goals were addressed. This gives excellent structure for preparing the learning environment and planning intentional instruction.

Technical assistance includes both a general and personal approach. We look for specific qualities in the environment and instructional process; but also, the coach relates to every

teacher individually, and supports them in considering the needs of each child.

Q: What is one of the most difficult challenges facing Professional Development? **SM:** ALLOCATED TIME. This work is so important; it deserves our very best effort. Teachers need time to plan and reflect on the observations and assessments that help make that planning purposeful. All staff need more time to share observations and documentation of children's development and learning.

The support of supervisors to mentor their instructional staff can best take place when they have time to spend together as a team. In the classroom, the teachers and instructional aides need more time to have daily discussions and weekly strategic planning.

The SDCPFA coaching team has been challenged by the limited time teachers have to spend in thoughtful reflection. This is essential to professional development and especially to the field of early childhood education.

Q: What are you doing differently this year to improve the effectiveness of the Professional Development Team's work?

SM: This past year we convened job-alike groups of directors, supervisors, teachers and instructional aides to ask them what they needed for professional growth. We added their suggestions to our previous experience for providing technical assistance and designed new ways for greater collaboration in the professional development process.

This new process included creating a digital format for the professional development plans that record many of the goals carried out each year by every SDCPFA agency. The plans were developed to make visible the valuable work that is completed at each level, from agency to supervisor and from teacher to instructional assistant. They are easily shared electronically for instantaneous communication.

Then we set up opportunities for mentoring that offered vertical support between supervisory staff and instructional staff, and horizontal support among classroom staff as well as with job-alike peer buddies.

As a result of increased staff collaborations, the coaching team can be more effective in supporting changes to the overall quality of the programs. The agencies also benefit in having greater visibility of their accomplishments by documenting how goals are being supported at all levels.

Q: What are some of the cutting-edge developments in Professional Development that you would like to include in your practices in the future?

SM: The creation of digital documentation tools for all staff positions in early education is a first step in professionalizing our field. We need to sing the praises of all the tremendous work that goes into the educational process. Through observation, documentation, reflection and planning, we are able to individualize the learning opportunities for children from all cultures and abilities.

The next step is to increase communication by utilizing the newest technology for virtual learning communities and bring together all the great minds in our field. Creativity is the hallmark of child development professionals and wonderful ideas are often lost due to the isolation of classroom teachers. The potential of professional development for early childhood education would increase tremendously if teachers had a forum for sharing their successes in a way that makes visible the multiple possibilities for learning.

New networking opportunities require digital literacy and access to technology. These are both improvements we want to embrace for our profession. The access to shared knowledge, available from any place at any time, can be a great motivator for instructional staff eager to participate in discussion.

This Fall 2009 at a Saturday "Reflective Teaching" round table hosted by Grossmont Community College, instructional staff representing seven SDCPFA agencies joined educators from preschools, child care centers and family child care homes across San Diego County. At the end of the day, the greatest request on all the participant evaluations was "more time for discussion".

In the future, we need to provide innovative ways to increase the opportunities for discussion and reflection. We need to recognize the professionalism of early childhood care and education by making visible the importance of reflective teaching as the means of providing optimal learning opportunities for all children.
